Resolved by the City Council of the City of Berlin as Follows:

That the following budget be adopted and accordingly, the sum of Forty-Three Million, Four Hundred Thirty-Three Thousand, Eight Hundred Sixty-Nine and Fifty-Four Cents (\$43,433,869.54) be appropriated to defray the expenses of Berlin's City Government for the period of July 1, 2020 through June 30, 2021, less expected revenues, with the balance to be raised by taxation on real estate of the municipality.

3. Resolution 2020-14 Library Grant \$10,000 (1st read)

- 4. City Manager's Report
 - 1. We received bids for local delivery propane. The low bid was \$1.049 per gallon which is a savings from last year's price of \$1.289 per gallon. We also accepted bids for Boiler Services and for Electrical Services. Those went to Mechanical Services and Vaillancourt Electric respectively.
 - 2. Chris Dubey reports that BEMS is gradually returning to business as usual. BEMS has installed, tested, and is operating a new phone system, which greatly expands capabilities for the future, part of that being mobile integrated healthcare. This program, (MIH) aims to change the way that emergency medical services interacts with the public. It appears to be designed to cut down on non-essential transports and emergency room misuse. It is also, optimistically, going to provide, essentially, mobile house calls for important, but non-emergency medical issues. Berlin EMS is actively exploring this possibility, and the corresponding investment required to bring this progressive service to Berlin. Chris says he can provide more information, or explain it better to anyone that is interested
 - 3. A bid for mobile radios for the Fire Dept. were received on May 21, 2020. The bids require an initial down payment and financing over 5 years. The total 5 years costs are as follows:

- 4. The search for a new Finance Director continues. In the interim, I have reached out to Municipal Resources, Inc. for interim services. Tomorrow, Rita Donaldson, CPA from MRI will be here to learn about our finance processes. Rita will work both on site and remotely while we continue our search.
- 5. At the June 10, 2020 Chlor-Alkali Public Informational meeting the public was updated on the ongoing work on the Superfund Site. Through extensive research, it is now believed that the ultimate cost of clean-up will be much less than originally estimated and will be on the order of \$5M. This reduction makes if more cost effective for mercury waste to be removed from the site and deposited at another location rather than interned on-site as thought earlier. EPA is accepting public comments on the clean-up plan through July 3, 2020.
- 6. A Fire Department incident report for the month of May is attached.

Councilor Rozek moved, with a second from Councilor Higbee, to accept the City Manager's Report and place it on file.

Councilor Rozek asked Chief Watkins if the bids received for the radios were for the model he wanted. Chief Watkins advised they were.

6. PUBLIC COMMENTS

Richard Laflamme of 128 Jasper Street asked the Council what they were going to do about \$5 garbage bags with multi-unit apartment buildings, how you would know what is theirs. Laflamme also mentioned that he has a swimming pool that he does not empty into the sewer, but pays outrageous sewer charges. Laflamme also mentioned that out-of-state garbage trucks are dumping here and ruining our roads while paying low tipping fees.

Mayor Grenier advised Mr. Laflamme that the Council was not entertaining instituting a pay-as-you-throw system at this time. The Council is looking at options for how to handle solid waste, and listened to a presentation on this system.

7. Council Comments

Councilor Rozek asked that the Council discuss the urban compact on Route 110 at a future meeting.

Councilor Remillard thanked the Mayor, City Manager, and Finance Director for the time they have spent working on the budget and stated she is pleased with the reduction in taxes.

Councilor Eastman thanked everyone for their hard work this year. Councilor Eastman also agreed that they need to discuss Route 110, along with extending the water and sewer in that area. Councilor Eastman advised the state will fix the culverts and resurface the road under the 10-year plan.

Councilor Rozek thanked the Mayor and Council for the hours they have spent on the FY2021 Budget, listening to the needs of the municipality and the citizens.
