1. Ordinance 2019-05 Rescinding No Parking on Main and Eighth Street by Brown School (tabled 09/03/2019)

In the year of our Lord Two Thousand Nineteen

AN ORDINANCE amending the CODE OF ORDINANCES, Chapter 15, TRAFFIC AND VEHICLES, ARTICLE III. STOPPING, STANDING AND PARKING, Sec. 15-69. Prohibited at all times in designated places, rescinding "no parking" on Eighth Street and rescinding "no parking" on Main Street, both in the area of Brown School.

Be it ordained by the City Council of the City of Berlin, as follows:

That Sec. 15-69, is hereby amended by eliminating the "no parking" designations depicted below.

Sec. 15-69. Prohibited at all times in designated places.

(a)

Eight Street, south side, Main Street to Norway Street and be posted with signs stating, "No Parking between signs, Monday to Friday, 7:00 a.m. to 3:30 p.m. during school hours."

Main Street, west side, for forty (40) feet north of Eighth Street (Ord. 9/21/09)

This Ordinance shall be in full force and effect from and after passage.

NEW BUSINESS

- 4. City Manager's Report
 - 1. There will be a Public Hearing on the State's 10 Year Transportation Plan on Thursday, September 19th, at 1:00 p.m. in the City Hall Auditorium. The purpose of the Ten Year Plan is to develop and implement a plan allowing New Hampshire to fully participate in federally supported transportation improvement projects as well as to outline projects and programs funded with Sate transportation dollars. The document can be viewed on DOT's website.

- 2. Berlin Ambulance has forwarded its monthly statistics and they are attached. Chris Dubey informed that BEMS anticipates delivery of a new van on or about the 17th of this month. They are also acquiring new "X series" defibrillators and they are working the possibility of acquiring refurbished power lift stretchers.
- 3. The House and Senate will both meet this week to consider override votes- the House, on Wednesday, September 18th, and the Senate, on Thursday, September 19th. Below are some of the bills in which municipalities have a strong interest.

4. Engine 1 sustained some minor damage at a fire at 388 Westcott Street on Saturday, September 7th. A claim was filed with Primex and is under review.

- **5.** Mayor's Report
 - a. Letter from Pam Bouchard

To: Mayor and City Council Berlin Police Department

At 7:45 a.m. on Thursday, September 5th, I wasn't wondering if I would live through the day. It wasn't really a concern until I attempted to go through the High St./School St. intersection on that clear dry morning.

I never saw what hit me. I just knew it was a vehicle coming from the southern end of School St. through the stop sign and into the front driver's corner of my vehicle, deploying the air bags, taking out the front of my van and injuring me.

Even though the other driver failed to stop, the bigger issue here is the cars that are parking too close to the corner along High St. Even when you do stop at the School St. stop sign, there is no way to see to the right if any cars are coming. Visibility looking left up High St. by the Baptist Church is adequate, but there is no trying to look through the cars that hug the corner to right of that stop sign.

For years now, drivers have had to inch their way through that intersection when those cars are parked close to the corner. It's getting ridiculous and dangerous.

I urge you to take this matter as serious as a heart attack. Expedite your discussions and pass whatever you have to in order to rectify this safety issue.

Should the city fail to act in a timely manner and should a FWTH occur; (FATALITY WAITING TO HAPPEN), then I guess someone will have to live with it. I know I'm just happy to not to dead.
