City Council Work Session November 6, 2023

At 6:30 p.m., Mayor Grenier read the 2023 Extra Mile Day Proclamation. This year, Mayor Grenier recognized the Nansen Ski Club's Board of Directors and Volunteers. They have demonstrated visionary leadership, tenacity and dedication, collaborative spirit, preservation of history, community engagement, and sustainability. FY2022 Audited Financial Statements

Land Use Change Tax Warrant
