**I. Call to Order:** 04:02 pm

**II. Roll Call:** Commissioners Nault, Tremblay, and Morin were present.

**III. Acceptance of Minutes of August 11, 2021.** There was an amendment made with reference to the attendance: Chief Morency and Captain Lemoine were not present. Also, a correction with reference to kickball as it made Facebook but not the paper. Minutes were unanimously accepted as amended on a motion from Comm. Morin seconded by Comm. Tremblay.

**IV. Monthly Financial Report:** Reports were reviewed and discussed. The financial report was unanimously accepted on a motion by Comm. Tremblay, seconded by Comm. Morin.

**V. Old Business**

- A. Stalking Petition:** Went before Judge Boyle who threw it out. Arrested the complainant the following day and he had a tattoo with Lt Daisey's name.
- B. LEACT Police Misconduct Board:** The department already has a way, internally, to handle misconduct; the Commission plays a role in handling misconduct, as well as the courts have a way. Fear is that they may try to strip the Comm. on having any authority. There is already a system in place and it is unknown what role this board may have.
- C. School Resource Officer:** Met with the school district with reference to how to move forward considering there is no SRO in place. An ad has been placed on INDEED. The department will continue to work to fill the gap.
- D. Cates Hill Antenna:** Jenn advised the Commission that AVH is interested in selling the City of Berlin the tower for \$1. Jenn obtained a copy of the agreement from AVH. Did consult with OME with reference to the structural integrity of the tower and they advised it is sound.
- E. Other:** Grant that would pay to reprogram the radios. Question on whether a resolution

would be needed.

- Captain Lemoine provided an update with reference to the Golf Tournament. We are up to 104 players but there may be an issue with getting enough golf carts. Donations are down this year.
