

Board Of Assessors Minutes of Meeting October 24, 2019

1) CALL TO ORDER

The meeting was called to order at 3:30 PM.

2) ROLL CALL & PLEDGE OF ALLEGIANCE

Chair Robert Goddard – In attendance Member Kem Rozek –In attendance Member Mark Eastman – In attendance

Those in attendance recited the Pledge of Allegiance.

3) REVIEW & APPROVE MINUTES DATED AUGUST 2, 2019

The minutes of the meeting of August 2, 2019 were sent to members of the Board prior to this meeting. Robert Goddard noted that the minutes should reflect that the Board has requested the utility value workfiles from Sansoucy's office a total of five times, instead of three as noted on page one of the minutes.

Mark Eastman made a motion to accept the minutes as amended. Robert Goddard seconded the motion. All were in favor, inclusive of Kem Rozek. The motion carried.

4) 2018 BTLA APPEALS AND UTILITY APPEAL DISCUSSION

Members of the Board reviewed a list of 2018 tax appeals filed with the BTLA, (See Appendix A)

Additionally, the group reviewed three appeals filed at the NH Superior Court by utility companies – Public Service Company of New Hampshire, Central Rivers Power, and Northern New England Telephone Operations. It was noted that all assessing matters in the City fall under the purview of the Board of Assessors and thus the group must be kept apprised of the details of all tax appeals. Members of the Board would like to be kept abreast of the appeal situations to a greater degree than is currently the case with these utility appeals.

5) 2019 EXEMPT PROPERTY REVIEW

Members of the Board reviewed the BTLA A-9 and A-12 forms that were submitted by organizations seeking an exemption from real estate taxation for institutional reasons. These entities must be either religious, educational, or charitable in nature and must comply with all NH statutes related to the tax exemption. (See Appendix B)



6) <u>193 MT. FORIST STREET – EXTERNAL OBSOLESCENCE DISCUSSION</u>

The owners of 193 Mt. Forist Street had inquired why the 5% external obsolescence factor was removed from their tax card. Members of the Board discussed the situation and were in agreement that the obsolescence should not be reapplied to the parcel. This is because the commercial activities originating from outside of the property violate zoning regulations and therefore become an enforcement issue and not an assessing issue.

While reviewing the tax card, Board members noticed that the depreciation of the garage was listed as 25%. Data collection guidelines set forth by KRT Appraisal indicate that an outbuilding should have a minimum of 50% deprecation for tax purposes. Members of the Board will view the property and discuss the correct percentage to assign to the garage at the next meeting.

7) 2019 SALES STUDY UPDATE

The group reviewed an unofficial study of qualified sales that occurred between October 1, 2018 and September 30, 2019. A study of these 137 qualified sales indicates a median ratio of 0.89, or in other words, the City is assessing property at 89% of market value. An official sales study will be finalized by the Department of Revenue in early 2020.
