That the following budget be adopted and accordingly, the sum of Thirty-Nine Million, Eight Hundred Seventy Thousand, Nine Hundred Twenty Dollars (\$39,870,920) be appropriated to defray the expenses of Berlin's City Government for the period of July 1, 2017 through June 30, 2018, less expected revenues, with the balance to be raised by taxation on real estate of the municipality
