- 1. The Androscoggin Valley Regional Refuse Disposal District will conduct its 27th annual Household Hazardous Waste Collection on Saturday, June 30th, from 8 a.m. to 1 p.m. at the District Transfer Station, 100 West Milan Road, Route 110, Berlin
- 2. We received bids on local delivery propane on June 12, 2018 at \$1.519 per gallon from CN Brown. Last year's price was \$1.149. One other bid from Irving (\$1.509) was rejected on the grounds that they took exception to the published terms of the contract.
- 3. Bids for a Welcome Sign were opened on June 5<sup>th</sup>. The results are below. The project has been awarded and the contract agreement should be executed soon.
