Councilor Higbee noted that he appreciates the Police Department and Fire Department applying for grant money to supplement tax dollars.

10. City Manager's Report

- 1. Attached is the Fire Chief's February report, the Monthly Incident Report and the EMS call volume report.
- 2. Attached is the February 2023 Property Transfer list.
- 3. Also attached is the 2022 AVRRDD Budget Report.
- 4. Per City Ordinance Sec. 15-81, City's parking ban will be lifted 4/1/23. During the month of April, the Police Chief is authorized to prohibit parking on City streets between the hours of midnight and 7:00 AM if required for snow plowing and removal operations.
- 5. The City's CMOM report has been filed with both DES and EPA. This report covers the capacity, management and operations of the sewer collection and treatment system. Next steps are to update our industrial discharge permits and process at present we have agreements with industrial dischargers and DES prefers a permit-based system. After that we will be moving toward a comprehensive review of sewer ordinances.
- 6. As the winter weather subsides DPW staff will be starting to analyze and classify the condition of our sewer collection system, identifying critical areas of need. Staff has been trained on both use of the camera and how to classify underground assets, using industry standard grading. The benefits are twofold damaged areas that may cause backups can be identified as well as sources of inflow and infiltration.

Councilor Roland Theberge asked if the salt shed would be similar to the one for AVRRDD, and City Manager Warren advised it will be a fabric covered metal structure.

Councilor Morency moved, with a second by Councilor Morgan, to accept the City Manager's Report and place it on file. So moved, the motion passed.

11. Mayor's Report

a. BIDPA Appointment – Amber Bachner

Councilor Berthiaume asked about the comfort dog program mentioned in Resolution 2023-10. Chief Buteau advised that the grant would cover this program, but they are still looking into the feasibility of it and advised it is not confirmed.

Councilor Morency thanked City Manager Warren and Director of Strategic Initiatives Pamela Laflamme for their help in arranging for the Homeowner Assistance Fund workshop being held at City Hall tomorrow. Councilor Morency noted that this is a great opportunity for people to get assistance that need it.

Councilor Robert Theberge advised that HB142, concerning Burgess Biopower, will be heard late Thursday in Concord. Councilor Theberge advised that he plans to testify in the Senate, as he did in the House. Councilor Theberge stated that it looks like the bill will be moving on, which will avoid a catastrophe for the City.

14. Adjournment

On a motion by Councilor Roland Theberge, seconded by Councilor Morgan, the Council voted to adjourn the meeting at 8:06 pm. So moved, the motion carried.
