PUBLIC HEARING - SEPTEMBER 19, 2016

Mayor Grenier opened the duly scheduled and advertised Public Hearing at approximately7:47 p.m. to hear comments on the following subject matters:

Resolution 2016-23 carrying over \$60,373.14 of Grant Funds from the year ended June 30, 2016 which are not yet expended to Fiscal Year 2017. There were no comments and Mayor Grenier closed the public hearing at 7:47 p.m.

A public hearing was opened for Resolution 2016-24 – R1 carrying over \$1,688,358.05 of Capital Appropriations from the Fiscal Year ending June 30, 2016 which are not yet expended to Fiscal Year 2017. There were no comments and Mayor Grenier closed the public hearing at 7:51 p.m.

A public hearing was opened for Resolution 2016-25 appropriating \$20,000.00 to the Police Department Special Project Enforcement (01-420-114-0000) from Unappropriated Fund Balance.

Peter Morency, 1944 Riverside Drive (Police Chief), stated that he wanted to make sure that the Mayor and Council understood the difference between Resolution 2016-25 and 2016-26. The monies indicated in Resolution 2016-26 are monies that the City has received from other entities such as Coos County Delegation and Camp RZR. The City needs to create an account to place the incoming monies into so that in turn the City/Police Department will have the ability to spend the money.

There being no one wishing to speak further regarding the subject matter at this time, Mayor Grenier declared the Public Hearing portion of the meeting closed at approximately 7:52 p.m.

CITY COUNCIL MEETING - Monday, September 19, 2016

Mayor Grenier called the Regular City Council Meeting to order at approximately 7:52 p.m. in the City Hall Council Chambers. The pledge of allegiance to the flag preceded roll call. Present: Councilors Remillard, Otis, Morgan Allain, Gentili, Higbee, Rozek, Nelson and Theberge. Also present: James Wheeler, Susan Tremblay, Barbara Tetreault.

Minutes, Previous Meeting

Councilor Remillard moved with a second by Councilor Otis to accept the minutes of the September 6 Regular Meeting/Work Session. So moved, the motion carried.

Disbursements:

Disbursement Summary Draft #1773 start date 9/7/2016 end date 9/19/2016 for a total cash disbursement of \$1,971,835.14. Councilor Theberge moved with a second by Councilor Higbee to accept the disbursement summary and pay all bills as recommended by the Committee on Accounts/Claims. So moved, the motion carried.

PUBLIC COMMENTS

Joyce Labrecque, 46 Pershing Avenue – Ms. Labrecque stated that she would like the City finish the Hutchins Street project as it relates to the proposed street lighting. She asked what the City has done to date to raise the money and wondered if there was anything that she may be able to do to assist the City.

Mayor Grenier stated that the Hutchins Street project was completed with mainly grant monies, noting that the City's share of the project was \$100,000. At this time the City does not have any plans in place to complete the lighting project. It will need to be set up as a Capital Improvement Project.

Councilor Theberge informed Mrs. Labrecque that the lighting project will cost just over \$200,000. He is, however, in agreement that he would like to see the lighting project completed for the safety of pedestrian traffic. It will also assist with beautifying the City.

Ms. Labrecque stated that she knows that the original plans for lighting include 27 lights. This amount seems to be excessive. She feels that 10-15 lights would be acceptable and suggested that the City revise the lighting plan.

Roland Labrecque 46 Pershing Avenue – Mr. Labrecque asked if the City had anything in place so that donations may be made by residents for this project. Mayor Grenier stated that currently there is nothing in place and said that the City would need have their legal department review the matter. At this time, he feels that this is the responsibility of the City and that the project should be addressed as having two phases. The lighting is phase two of the project.

Mayor Grenier thanked everyone for their input.

UNFINISHED BUSINESS

- 1. <u>Council Committee Reports</u> Councilor Rozek stated that the Traffic Safety Committee met prior to this meeting. He noted that they reviewed the following agenda items:
 - 1. Minutes
 - 2. Jericho Road Councilor Rozek stated that the Police Department was in attendance and could answer questions. Officers from the Department have attended special schooling for to learn how to use the decibel meters. The Police Department is setting up the radar cart and have decibel meters.

Public Works will set up an information center at the Veteran Park as well as re-route traffic for the RZR event. 3. Handicap Sign Oak Street – Councilor Rozek stated that this request was denied. The resident has their own personal parking spot available on their property. The Committee is concerned to set a precedence and/or the resident will use the proposed space as their own personal parking spot.

- 4. Burgess Bioplant Mike Perreault, PWD, Police Chief Peter Morency, , have spoken with Carl Belanger of the Bioplant regarding parking on Community Street. It is anticipated that an Ordinance will be drafted and brought before the Mayor and Council.
- 5. OHRV Ordinance The Committee will meet in November to start reviewing details as they relate to noise and youth operation on streets prior to the 2017 riding season.
- 6. Street Lights The Committee reviewed a request for additional street lights from Twelfth Street to White Mountain Lumber. The request was made because of the increase in traffic due to the prisons. Councilor Rozek noted that there are left over lights that may be able to be placed along Hutchins Street, using the poles opposite of the sidewalks. Councilor Rozek stated that the matter will be discussed again at the October 24th meeting. Mayor Grenier asked City Manager Wheeler to look at using left over cobra light heads along Hutchins Street until such time as the City can obtain period lighting.

Councilor Higbee moved with a second by Councilor Morgan Allain to accept the Council Committee Report as presented by Councilor Rozek and place it on file. So moved, the motion carried.

10. City Manager's Report

- Estimated voter turn-out was 22%. The Attorney General's office visited and inspected
 the St. Anne's location during their North Country tour. The AG's representative made
 a few small requests related to the layout of aisles and tables which were implemented
 while he was present.
- 2. The "go live" date for the City's new web site is September 23, 2016. The new look will be cleaner and easier to navigate; however it is still a work in progress.
- 3. The Fire Department's Incident Report for August is attached. On Friday August 16th there was a forest land fire in the vicinity of the Burgess St. Reservoir. The fire was determined to be in Gorham, however, Berlin FD assisted in the operation. A total of 42 multi-agency personnel fought the fire. Fortunately, and to everyone's credit, there were no injuries. Berlin, Gorham, Milan, New Hampshire Forest and Lands, Berlin EMS, Gorham EMS and the Red Cross responded. The residents on Burgess St. were very understanding with the parking of equipment. The UTV and boat were both utilized. Due to the rough terrain it was easier and faster to shuttle equipment across the Burgess Reservoir to the fire.
- 4. Community Field has received a new placement of certified playground wood chips at the base of the play equipment.
- 5. Among the many Camp RZR preparations, Mark Belanger of the AVCOC is organizing a Welcome and Information Center to be set up on Glen Ave. adjacent to Veteran's Park. He is working with Public Works and the Police Dept. on the traffic pattern design. Anyone interested in volunteering some time at the welcome center on Friday or Saturday should contact me directly.
- 6. The New Hampshire Municipal Association issued a publication in August 2016 that gives a history of State aid and the effect it has had on local property taxes. Local revenue depends on property taxes and any reductions in State aid programs shifts costs to municipalities. The report can be found at https://www.nhmunicipal.org/Resources/LegislativeBulletin/117.
- 7. There will be a Fall Program Series called "Women Out of the Kitchen" Historical Women of New England at the White Mountains Community College Fortier Library on Wednesdays in October. The series is sponsored by the NH Humanities Council, the Berlin Public Library, the Gorham Public Library and White Mountains Community College. A flyer giving the dates and descriptions of each program is attached.

Councilor Rozek moved with a second by Councilor Higbee to accept the City Manager's Report and place it on file. So moved, the motion carried.

11. Mayor's Report

Mayor Grenier took a moment to thank the people who worked at the polls during the recent Primary Election, noting that it really is a practice run for the Presidential Election. It is difficult to find folks to work the polls and it is a long day for the workers; their hard work and dedication is appreciated.

Councilor Rozek moved with a second by Councilor Theberge to accept the Mayor's Report and place it on file. So moved, the motion carried.

Councilor Otis wanted to make sure that the ATV operating hours will be extended for the upcoming event and is being advertised as such.

Councilor Nelson stated that since she was in direct contact with Polaris regarding a portion of the monies outlined in Resolution 2016-26, she will be abstaining from voting on the matter.

Councilor Remillard thanked all those who participated in the Church dinner last week.
