City Manager's Report

- 1. Bids were opened on Thursday, March 7th for the provision of the Summer Food Program held at City playgrounds during the summer. Tri County CAP was the low bidder and we are pleased that they will continue to provide the service.
- 2. The Annual Rabies Clinic will be held at the Recreation Center on Saturday, April 6th. The clinic is sponsored by the White Mountain Beagle Club in conjunction with the Lancaster Veterinary Hospital. Cats will be vaccinated from 10:00 to Noon and dogs will be vaccinated from 1:00 to 4:00 p.m. There is a fee of \$15.00 for rabies vaccinations and other vaccines will be available for an additional fee.
- 3. NH DOT does a yearly inspection of all bridges in the State including those owned by municipalities. Berlin currently has one red listed bridge: Mason Street over the canal built in 1967 and modified in 1977. The substructure is noted as being in poor condition. A letter from Victoria Sheehan, DOT Commissioner to Governor Sununu is attached. This is the same issue discussed with Council last fall. We want to continue to monitor the substructure at least once annually and put the bridge in the State Aid Bridge Program for ultimate repair.
- 4. A selection committee met on Tuesday, March 12th to review the proposals and interview firms for the Library Building Assessment. The following firms submitted and interviewed for the project:

AECm Engineering Alba Architects IIb Tennant Goucher Architects

The firm selected for the project is Alba Architects.

- 5. Join your fellow community members, friends and neighbors at the kickoff event for the Berlin Industrial Development & Park Authority Board's economic development strategy work. In accordance with RSA 234:25-b Inspection of Red List Bridges: Report, enclosed please find the 2018 submittal of state and municipal Red List bridges, compiled by the New Hampshire Department of Transportation. For your use and reference, enclosed please find copies of these 2018 Red Lists, which are based on inspection data gathered through December 31, 2018. This information shows that during the 2018 inspection cycle the number of State Red List bridges decreased from 133 to 129, and the Municipal Red List decreased from 252 to 241.

As required, copies of this letter and the Red List information will be distributed to other elected officials and to the municipalities, via email and/or paper copies. Additional bridge data, including State and Municipal Red Lists, can also be found on the NHDOT Bridge Design web page at http://www.nh.gov/dot/org/projectdevelopment/bridgedesign/documents.htm. All bridge inspection data is gathered in accordance with the National Bridge Inspection Standards (NBIS), per Federal Highway Administration (FHWA) regulations.
