Re: City Manager's Report

- A mandatory pre bid meeting for Route 16 was held on March 17<sup>th</sup>. There were six contractors present. The bid opening for this project is April 14<sup>th</sup> at 2:00 p.m. The bid opening for Hutchins Street is tomorrow at 2:00 p.m. In addition, attached are progress reports from HEB for both projects.
- 2. Bids for 56 Iceland Street were open March 10, 2016. The property had a minimum bid of \$5,000 and it was sold to Kris Saunders for \$5,225.
- We welcome Michel Salek to the Building Inspector position. Michel has been with working in the Public Works Department since October of 2014. He comes with a solid technical background in engineering and practical experience in construction.
- 4. Attached is a letter from the NH Department of Safety notifying officials that Bounce Houses used at a private residence are not regulated; however if an inflatable Bounce House is to be used at an event then it needs to be registered per RSA 321-A. A registered bounce house will have a NH Decal with the current year and a number. The operator should also have registration documents and an insurance certificate on hand. There is more information and there are contact numbers in the letter.
- Attached is a flyer from the Local Government Center announcing the Local Officials Workshops for this year. The closest event location to Berlin is the workshop to be held Thursday May 19 in Whitefield.
- 6. A copy of the City's 2016 Dog License Fees is attached along with a notice of the April 9, 2016 Rabies Clinic to be held at the Recreation Center from 1:00 to 4:00 p.pm.
- 7. This is to notify you that we are working on behalf of BIDPA to have a tree clearing and timber sale project on approximately 30 to 40 acres of the land recently purchased on East Milan Road. BIDPA will be leaving a buffer trees around the perimeter of the property that will be approximately 100 feet deep along properties where there are residences.

Dear Administrator,

The NH Bureau of Tramway and Amusement Ride Safety regulates amusement rides and devices through the New Hampshire Division of Fire Safety, or Fire Marshal's Office. 'Bounce House' inflatable — type devices meet the definition of an amusement ride, and are regulated if they are 'open to the public'. This means that if an inflatable device is used at a private residence, then it is not regulated, but if it is used for any other use, such as a church gathering, old home day, or school function, for example, then it is regulated, and needs to be registered. This poses a challenge for our two inspectors statewide, as we find it impossible to know where and when these devices are used, because of the relative simplicity of setting them up and operating them.

We are therefore reaching out to the town administrators in hopes that we can 'get the word out' that these devices come with particular risks, and are regulated in an effort to minimize those risks. Please pass this message on to the police and fire departments, so that they can be on the lookout for these devices.

Each registered device will have a New Hampshire Decal with the current year and a number. The operator should also have on hand a copy of the registration documents and an insurance certificate. If an operator does not have this, then operation of the device is in violation of RSA 321-A.

Please keep our contact information available, and feel free to contact us if you have a question regarding amusement devices.


