Re: City Manager's Report

- 1. There will be a Public Hearing on the State's 10 Year Transportation Plan on Thursday, September 19th, at 1:00 p.m. in the City Hall Auditorium. The purpose of the Ten Year Plan is to develop and implement a plan allowing New Hampshire to fully participate in federally supported transportation improvement projects as well as to outline projects and programs funded with State transportation dollars. The document can be viewed on DOT's web site.
- 2. Berlin Ambulance has forwarded its monthly statistics and they are attached. Chris Dubey informed that BEMS anticipates delivery of a new van on or about the 17th of this month. They are also acquiring new "X series" defibrillators and they are working the possibility of acquiring refurbished power lift stretchers.
- 3. The House and Senate will both meet this week to consider override votes—the House, on Wednesday, September 18th, and the Senate, on Thursday, September 19th. Below are some of the bills in which municipalities have a strong interest.

4. Engine 1 sustained some minor damage at a fire at 388 Westcott Street on Saturday, September 7th. The damage not affect the operation or the functionality of the engine, however some of the lights and stickers were melted, and all the rear compartment doors have been wrinkled or distorted from the heat. A claim was filed with Primex and it is under review.

- 5. The BTLA granted a Motion to Extend the deadline for responding to its order regarding tax abatements until September 30, 2019
- 6. The White Mountain Community College has invited the Council to an informational dinner prepared by the students and faculty of their Culinary Arts and Baking and Pastry Arts Program Wednesday, October 2nd from 5:00 to 7:00 p.m. Please RSVP prior to September 25th.
- 7. The filing period for the November 5th, 2019 election will begin Monday, September 23rd at 9:00 a.m. and will end Monday, October 7, 2019 at 4:00 pm. Candidates must be registered voters in the City of Berlin. Candidates for Mayor must have been a Berlin resident for at least two years and candidates for City Council must have been a Berlin resident for at least one year.
- 8. Burgess BioPower will be going before the Planning Board at their October meeting for a Preliminary Design Review of their plans for an onsite greenhouse project.
- 9. Chris Fournier, PE and structural engineer from HEB reviewed the west span of the Mason St. bridge and will be working with the City in planning for this project. Mr. Fournier also reviewed the Fire Dept. structural floor condition and will be helping us with repair/capacity improving recommendations.

At the January 10, 2012 Election, Berlin Voters passed a City Charter Amendment to reduce Berlin's four (4) wards to one (1) single ward. For Election purposes only, Council voted to keep the same four (4) voting districts as they were. The voting districts are now referred to as voting precincts.
