1. Route 110 resumed work on April 18.

- 2. A meeting of the Androscoggin River Committee was held on Thursday April 14th at the Mahoosoc Inn in Milan. The group plans to nominate the Androscoggin River to the NH Rivers Management and Protection Program. There were comments both for and against the proposal. If the nomination is submitted, there is a two year process that will need to get through the Legislature. Barbara Tetreault wrote a very comprehensive article about the meeting. A copy is attached in case you missed it.
- 3. Congresswoman Annie Custer sent us a letter offering assistance for her constituents. Included is a contact list for her offices. The information is attached and it has been posted to the City web site.
- 4. Warner Cable is negotiating agreements with programmers and broadcasters whose services are set to expire. A list is provided in the attached letter from Warner Cable. This is a routine process and in most circumstances agreements are reached before programming is affected.
- 5. After 10 years with the same website, we are in the planning stages of updating and refreshing the City's website. We are staying with our current company, Virtual Town and Schools and will be upgrading to their newest and most secure website platform. The change will allow departments to be in charge of their own pages. Currently, only three people manage the entire site. We may not be able to include all suggestions but we'd like to continue to make the site the best it can be so if Council has any suggestions, we would love to hear them. We hope these changes make the website more user friendly for citizens and staff. If anyone has any comments or suggestions, please let Sue and Pam know.
- 6. The Berlin Main Street Program is asking for volunteers on Friday, May 27th for the Berlin Downtown Day of Caring. They are looking for volunteers to help rake, prune, sweep, mulch, weed, and plant their way through multiple sites in the downtown area. In appreciation for your dedication to the community, a barbecue is planned for lunchtime at Bickford Place for all volunteers. - 7. The Public Works Department monthly report is attached.
- 8. The Notice to Proceed for Hutchins Street was sent to AB Excavating on April 27, 2016. The project was given the approval to proceed by NHDOT. The expected Substantial Completion date of the project is July 8, 2016. In addition, Sargent Construction has notified the City that they do not wish to begin the Rte. 16 reconstruction project until mid-July. They feel they will be able to complete the project within the construction time allocated. This will further alleviate any concerns of congestion caused by both projects being underway at the same time.
- 9. On Wednesday May 18th, beginning at 6:00 p.m. in the Berlin High School Cafeteria, the recently formed Stand Up Androscoggin Valley Coalition, working with Sergeant Rick Frost of the NH National Guard Counterdrug Task Force Civil Operations, will host a free event inviting residents of the Androscoggin Valley to help identify all the activities and assets that already exist in our region. The event Embrace our Region is a next step in strengthening our community against substance misuse. Whether you and your family and friends like to hike Mt. Jasper or Mascot Mine, fish along the Androscoggin, spend an evening at the Medallion Opera House or St. Kieran Community Center for the Arts, we want to know what makes the area special to you.

An activity expo will follow in the Berlin High School gymnasium to conclude the event. The expo will showcase all the activities and great things that our area has to offer. We invite clubs, organizations, businesses – both formal and informal – to come and set up a table to share what they offer to the community so people can get more information and ideas. Group plans to nominate Androscoggin River to N.H. rivers protection program

BY BARBARA TETREAULT

MILAN — The Androscoggin River Committee held a public informational meeting Thursday to outline its plan to nominate the Androscoggin River to the N.H. Rivers Management and Protection Program.

The plan, if approved, would provide recognition of the scenic value of the resource, as well as additional protection for water quality and flow.

Phoebe Backler, New Hampshire outreach coordinator for the Northern Forest Canoe Trail and a Milan resident, explained that the committee, consisting of local business and landowners, non-

profit and government agency representatives, has been meeting for several years to discuss how to protect the river, while at the same time maintaining traditional recreational uses such as fishing and kayaking.

Bearcat armored vehicle used four times since it arrived

BERLIN — In the seven months the Berlin police department has had the Bearcat armored vehicle, it has been used four times for high-risk situations.

"We are very careful — we take it out only when we need it," said Deputy Chief Dan Buteau, mindful of public concerns that the Bearcat would become a common sight on city streets.

Meeting Thursday morning, the Bearcat committee reviewed the use log for the vehicle and discussed procedures that determine when the Bearcat is used.

The log shows that between Aug. 27, 2015, and March 24, 2016, the Bearcat was used four times. The log does not contain details about the calls but Buteau said all four instances have resulted in arrests.

Bureau said the Berlin Gorham Emergency Response Team has a matrix it uses to determine if the risk is high enough to require use of the Bearcat. He said the situation has to score above a certain risk level before the Bearcat is used.

Committee member Mike Rozek, who is also a city councilor, said most residents of the city have never seen the Bearcat. He said the department has not paraded it through the city. He said Berlin's objective in having the Bearcat is to save lives.

Executive Council approves development block grant for Capone Iron North Woods

BERLIN - The state Executive Council has formally approved the \$500,000 Community Development Block Grant for Capone Iron Corporation North Woods.

The city applied for the CDBG on behalf of Capone and the Coos Economic Development Corporation will act as the sub-recipient and retain possession of this loan, with the proceeds flowing back into CEDC revolving loan fund for use within Coos County.

Based in Rowley, Mass., Capone is a full-service steel construction company that provides expansive solutions for their customer's structural steel and metal needs. Owner Stephen Capone felt that there was a unique opportunity for expansion of his facility in the North Country.

The company last year purchased the former Hexaport building at the city's industrial park and renovated the building. Earlier this month, the company received site plan approval from the Berlin planning board to build a 16,000 square foot addition to the building.

The CDBG funds will be utilized for the purchase of equipment integral to Capone's manufacturing process. When construction is complete, the company expects to create 40 to 50 good-paying positions.

Some of Capone's past projects include: Saks Fifth Avenue, Boston, Mass., Filene's Basement, Westborough, Mass., and Patriot's Place, Foxboro, Mass.

Assisting with the project are the Berlin Industrial Development and Park Authority, N.H. Employment Security, and the N.H. Department of Resources and Economic Development.

Police Chief Peter Morency said the vehicle is never used for routine calls. The log showed the Bearcat has been used seven times for training exercises.

To address concerns that the Bearcat represents a militarization of the city's police force, the vehicle does not have a turret and a tear gas dispenser. Buteau said a permanent "Med Evac" sticker is used to identify it as a rescue vehicle.

The city council's decision last year to approve the \$274,553 grant application for the armored vehicle drew opposition. Residents appeared split with half saying the vehicle was an offensive weapon the city did not need and the other half noting the increase in drug use has created the danger for residents and police.

Mayor Paul Grenier supported the Bearcat but suggested the council establish a committee to review its operations to ease public fears.

While Berlin applied for the grant, the vehicle serves all of Coos County and the specially trained team includes law enforcement officers from Berlin, Gorham and the Coos County Sheriff's Department.

Serving on the Bearcat committee are Rozek and Councilor Roland Theberge, Robin Levertu, Police Commissioners Jerry Nault, and Marc Trembly although Tremblay was appointed to the committee prior to being named to the police commission.

She said there was a consensus that people do not want to see the river become another Saco River where heavy use has caused problems.

Injured hiker rescued on Sunday

HART'S LOCATION - New Hampshire Fish and Game Department, with assistance from corresponding local personnel, responded to two reports of injured hikers last weekend.

On Sunday, Fish and Game, along with Bartlett/Jackson Fire and Ambulance, Twin Mountain Fire, North Conway and Conway Fire Department, Appalachian Mountain Club, Androscoggin Valley Search and Rescue, Pemi Valley Search and Rescue and SOLO personnel responded to a report of an injured hiker on the Webster Cliff Trail in the White Mountain National Forest.

According to Fish and Game, Anny Bedard, 50, of Boston injured her left leg while hiking down the Webster Cliff Trail in Hart's Location.

Bedard had hiked to the top of Mount Webster with her husband and at 12:30 p.m. fractured her left leg while descending. Her rescue was delayed due to lack of cellphone coverage. A passing hiker came out and reported the injury at 2:45 p.m. Bedard attempted to continue under her own power but was ultimately placed in a litter and carried out 1.5 miles. She reached the trailhead at 7:10 p.m.



Backler said the intention of the program is not to control land use along the

Tracie Sales, watershed planner for the N.H. Department of Environmental Services, described the nomination process. She said there are 18 rivers in the protection program including the Connecticut River. Sales said the river protection program designation recognizes the river as special and provides some extra protection, particularly regarding water quality and in-stream flows. One restriction is that water withdrawals have to remain in the watershed. She noted the Balsams project, which would take water out of the Androscoggin River in Errol and return it to the Connecticut River watershed is already permitted and thus grandfathered. Sales said there are very few restrictions on land use and most of those already exist in other regulations.

The nomination must detail the specific river classifications being proposed. Ken Kimball, of the Appalachian Mountain Club and also chair of the N.H. Rivers Management Advisory Committee, noted the Androscoggin River is one of the most regulated rivers in the country with a series of dams maintaining a minimum flow. He said the local committee wanted the classifications proposed to represent current uses.

For those reasons, he said the group is recommending none of the river be classified as natural, which bans the construction of new dams or reconstruction of breached dams.

Instead the proposal places much of the river in rural and rural community classifications with a section in Errol

and the segment between Berlin and Gorham as community. All of those classifications allow motorboats and the community sections allow for new dams.

Backler said the committee plans to submit the nomination June 1 and is working until then to get public input and build support. She said the river classifications are not set in stone and input is welcome.

Once the nomination is submitted, at least one public hearing will held in a community along the river

Ultimately, the commissioner of DES must approve the nomination. It then goes to the legislature and the governor for final approval. Backler said it is basically a two-year process and she does not expect it will go before the legislature until next year.

If the nomination is approved, then the local advisory committee will develop a management plan for the river. The group will also review state and federal permit applications for projects on the river. The advisory group has no regulatory authority and cannot overrule local land and zoning regulations.

Jim Cochran, director of Enriched Learning Center, conducts summer educational programs on the river including whitewater rafting. He said he believes putting the Androscoggin River into the state protection program and setting up an advisory committee will allow local people to be heard.

"I really wanted to see a more local voice up and down the river," he said.

Mark Peabody of the Mahoosuc Inn in Milan said he realizes his business, which includes rafting, is bringing a lot of people into the area. He said the committee is trying to educate visitors so problems do not develop on the river.
"We're trying to be out in front of it,"

he said.




