City Manager's Report

- 1. Berlin City officials are kicking off the Route 16 Riverwalk project on June 5th at the Planning Board meeting scheduled for 6:30 to 8:00pm at City Hall. The Riverwalk discussion is expected to start at 7:00 PM. Berlin citizens and business owners are encouraged to come learn about the new multi-use Riverwalk Trail planned along the Androscoggin River on upper Main Street. This is the first of two meetings that will be held to collect citizen input and suggestions regarding trail placement and desired amenities.
- The Androscoggin Valley Regional Refuse Disposal District will conduct its 27th annual Household Hazardous Waste Collection on Saturday, June 30, from 8 a.m. to 1 p.m. at the District Transfer Station, 100 West Milan Road, Route 110, Berlin
- 3. I've attached a list of the Recreation Department's Summer Activities with dates and age groups. There is something for everyone... British Soccer Camp, Dancing and Tumbling, Basketball, Baseball, and Field Hockey.
- 4. The Sign up for the summer reading program is from June 4<sup>th</sup> to June 29<sup>th</sup> at the Library Children's Department. The theme is "Libraries Rock" and the Kick Off party is on June 21, 1-3pm at the Recreation Center with Dave Duchesne providing entertainment.
- 5. The Berlin Supervisors of the Voter Checklists (all precincts) will hold a session in the main lobby of City Hall Tuesday, June 5, 2018 from 7:00 p.m. until 7:30 p.m. to allow voters to change their party affiliation, to register new voters and to make corrections to the voter checklists. This is the last day to change your party affiliation for the September 11, 2018 State Primary Election.
- 6. We have a bid out for local delivery propane due June 12, 2018
- 7. The Department of Treasury has formally designated 27 census tracts around the state for federal designation as Opportunity Zones. Berlin's Opportunity Zone is north of the Industrial Park on East Milan Road. Opportunity Zones encourage long-term investment in the areas in which they are located. Created by the Federal Tax Cuts and Jobs Act last December, the program provides tax incentives for investors who reinvest unrealized capital gains into qualified Opportunity Zones.

- 8. The Fire Department submitted a report of activities as well as their monthly incident report.
  - a. Of note is that Engine 4 repairs are going well and the truck is scheduled for return at the end of June.
  - b. Assistant Chief Soltys and Building Inspector Salek are working on the annual inspections of Berlin's multi-family dwellings.
  - c. Work has begun on updating the City's Emergency Operations Plan which needs to be updated every five years.
- 9. The Assessing Standards Board chose its representative (in addition to Betsey Patten, Chair Person) to sit on the HB324 Commission. The Board chose member Tom Thompson of Orford, NH. Mr. Thompson holds a "member of the public" seat on the ASB.
- 10. I am continuing to advertise and seek ways to further develop the pool of applicants for the Public Works Director position before convening the interview committee. To date, responses have not been overwhelming.
- 11. Myself along with Members of Berlin Water Works, Berlin Public Works and Pollution Control met with Anne Getchell of the Rural Development Administration on May 24<sup>th</sup> to discuss RDA grant and loan programs. We took the opportunity to tell RDA about our upcoming projects to gauge the potential for RDA funding.
- 12. Dammon Frecker of Burgess BioPower joined us on May 31<sup>st</sup> to interview potential firms for the snowmelt feasibility study. Both firms interviewed were impressive. The two firms were selected out of five who submitted qualifications. We expect to make a selection this week.

Dear James,

On May 2, Governor Sununu designated 27 of the 106 low-income census tracts in New Hampshire as "Opportunity Zones." As you know, your community had one or more of these tracts designated.

The designated tract(s) for your area:

33007950600

The 27 census tracts in 23 New Hampshire municipalities and unincorporated places have the potential for investment and growth, are positioned to leverage state and federal dollars for economic development and have passionate ambassadors able to attract investors to the program.

The federal Tax Cuts and Jobs Act enacted in December contained a provision that created Opportunity Zones. The new Opportunity Zone program is intended to offer a tax incentive for investors to reinvest their unrealized capital gains into qualified Opportunity Funds. These funds will invest in projects located within Opportunity Zones, which are certified by the Secretary of the Treasury.

The goal of these Opportunity Zones is to spur economic development. Opportunity Fund investors will receive a deferral of taxes owed on unrealized capital, and if the investor holds the investment in the Opportunity Fund for at least 10 years, the investor will be eligible for an increase in basis of their original investment, which will mean significantly less tax owed at the end of the term.

As the program continues its roll-out over the next several months, the U.S. Treasury Department will provide further details, including additional legal guidance and rules on this new incentive. Our office will share that guidance on our website and will also provide information about an upcoming workshop specific to communities with designated Opportunity Zones.

Fire Department Report

- The Engine 4 frame rail replacement is going well and is still on schedule for the end of June.
- The City Seal has been added to the UTV, UTV Trailer and the Chief's car.
- The department's new repeater will be installed and all radios reprogrammed within the next several weeks.
- The gear washer and drying unit, the plumbing for the washer, and the electrical work have been ordered.
- The department's new air compressor developed a leak and even though it is out of warranty, our supplier (NAPA) is replacing the compressor at no charge.
- Captain Berthiaume's shift has begun demolition in the building next door to the department to create more storage space. He has also donated a garage door so that we can have larger access between the heated portion of the space where we store apparatus and the new cold storage space.
- The annual inspections of Berlin's multi-family dwellings have begun. Both the Assistant Chief and the Building Inspector have been working together on this project.
- I have included the Air Quality Report for the department's air compressor that provides air for our self-contained breathing-apparatus and the cascade system for our Ladder.
- In the next several weeks, Primex will be performing a risk assessment audit at the department. I made the request in order to be proactive in minimizing incidents of injury.
- Speaking of Primex, they will be here during the month of June providing Confined Space Entry training for the department's shifts as well as Wastewater Treatment. Training is provided at no cost to the City.
- The City Manager and I have begun the process of updating the City's Emergency Operations Plan. The plan needs to be updated every five years and we will beginning the update in late summer and early fall.
- We will be working with the VFW and the Bryant Funeral Home in order to "dress" up the flag pole area. Years ago, our flag pole was dedicated to Berlin resident Daniel Albert who died serving his country in Vietnam. Retired Captain Bill Maddalena wanted to honor his service in a more significant way so, working with Ed Bryant from Bryant Funeral Home, they'll be placing a monument near the flag pole dedicated to Mr. Albert. In talking to Capt. Maddalena and Mr. Bryant, I felt that it would be appropriate to clean up the area and dress it up to honor Mr. Albert's service. Several guys have committed to volunteer their time to help on the project over the course of the summer.
