THE NEW HAMPSHIRE PROCUREMENT TECHNICAL ASSISTANCE PROGRAM PRESENTS THE BUREAU OF PRISONS PURCHASES OF GOODS AND SERVICES REPORT

This report was prepared to provide a source of guidance for local businesses who hope to become sources of service and supply to the new Federal Correctional Institution currently under construction in Berlin, New Hampshire. It is an attempt to provide some insight into the frequently asked question: "What will they buy?" Businesses may examine this spending history, consider the data for each institution included in this report that pertain to their type of business, and develop some sense of the types of goods and services that these institutions typically buy, the frequency that they make these purchases, the quantities that they purchase and the number of dollars that they spend. Some sense of the variability between institutions, which may be substantial, can be attained.

Those desiring more detailed information are invited to visit FPDS - https://www.fpds.gov, where they may register as a user and obtain further information. We expect that businesses will use the data to evaluate the magnitude and nature of business opportunity that FCI Berlin may represent to them. We hope that this will help to make prudent decisions regarding what offerings they might add in their business, what product/service areas that they might expect and prepare for growth, and what will likely be unaffected.

This document was prepared using information acquired in the Federal Procurement Data System (FPDS) - a free, public database which reports all Federal government procurement actions in excess of \$3,000. The Federal Correctional Institutions identified for us by Cathi Litcher of the Bureau of Prisons (BoP) used for comparison were Elkton, OH, Ray Brook, NY, Otisville, NY, Fairton, NJ and Greenville, IL. For fiscal year 2008 the five Federal Correctional Institutions (FCI) identified were similar in facility design and size, climate, gender and age distribution of the inmate population to the Berlin, NH FCI.

The information contained is meant to be used as a guide only, for companies seeking to do business with the Berlin, NH FCI.

The information contained in this document is only as accurate as that provided on the award notices in the FPDS. In some instances there was no description of services provided - just the dollar amount spent. Procured products and services are bought in various ways: GSA Schedule, five year contract awards, one year contract awards, semi-annual, quarterly, with a Government purchasing card (credit card) or on an as needed basis for some items. The procurement method information is not always entered on the award, thus could not always be provided. Please note that purchases under \$3,000, commonly made locally using government credit cards (P-Card) are substantially under-represented in the data, because they are not required to be reported in FPDS.

The Abridged Catagories & Amount Spent page contains information in a semi-breakdown form of dollars spent by major categories. For instance, Spiritual, Food & Utilities has a total spent for each FCI and at the end of the line item the total spent on those items for all facilities. At the bottom of the column for each FCI is the total amount spent at that facility. For each FCI there is a separate detail worksheet of all expenditures for FY 2008 as found on FPDS. Purchases of similar commodities can vary facility to facility, in some instances they can be almost the same and in other instances procured for one facility but not at another.

No attempt has been made to include personal purchases made by BoP staff, their families, and the families of inmates who may visit or relocate to the area. Together, these two additional sources of business are likely to represent a very significant addition to the total economic impact of the FCI on the local economy.
