ANTICIPATED CONSTRUCTION PHASING

- **Phase I** Mill and Overlay (Twelfth St. north)
- **Phase II** Full Reconstruction (Seventh Eighth St. and Twelfth St. intersection)
- **Phase III** Full Reconstruction (St. Anne's Church to Twelfth St. intersection, excluding Phase II area)

WORK PROGRESS (Last 2 Weeks)

- **Phase I** Complete.
- **Phase II** Nearly Complete.
 - Completed wearing course pavement installation.
 - Completed several improvements near Twelfth St. Bridge including curbing, traffic signals, and guardrail.
- **Phase III** Nearly Complete.
 - Completed wearing course pavement installation.
 - Completed paving of several driveways.
 - Continued installation of concrete pavers adjacent to the new sidewalk.

WORK SCHEDULED (Next 2 Weeks)

- Phase II
 - Complete concrete sidewalk and paver installations.
 - Complete pavement markings (centerline, shoulder, and parking).
 - Complete traffic signal improvements at Twelfth St. intersection.

Phase III

- Complete concrete sidewalk and paver installations.
- Complete pavement markings (centerline, shoulder, and parking).
- Complete paving of remaining driveways.
- Complete back-of-sidewalk work (yards, walkways, etc.)



MAINTENANCE OF TRAFFIC

Detours will likely be utilized during installation of pavement markings. One-way alternating traffic will be maintained throughout the remaining project area as concrete sidewalk and driveway paving is being completed.

The current schedule includes the following:

• Pavement Markings: Friday, 10/27

• Driveway Paving: Tuesday, 10/31 or Wednesday, 11/1

• Back-of-Sidewalk Work: Friday, 10/27 – Friday, 11/10

With project completion anticipated in two to three weeks, this will be our last report. Thank you for your continued patience throughout the project!
