Nicole Plourde suggested filling the need for an additional elementary teacher position at Brown by transferring a teacher from a school where class size is lower.

CHROME BOOK	The Board was given training on the use of Chrome Books after the meeting adjourned. The Board meeting packets will now be done electronically.
