A RESOLUTION adopting a budget in the amount of Forty Million, Four Hundred Ninety-Six Thousand, Six Hundred Twenty-Five Dollars (\$40,496,625) and appropriating such to defray the expenses of Berlin's City Government for the fiscal year 2019

Resolved by the City Council of the City of Berlin as Follows:

That the following budget be adopted and accordingly, the sum of Forty Million, Four Hundred Ninety-Six Thousand, Six Hundred Twenty-Five Dollars (\$40,496,625) be appropriated to defray the expenses of Berlin's City Government for the period of July 1, 2018 through June 30, 2019, less expected revenues, with the balance to be raised by taxation on real estate of the municipality


