

RE: HIGHWAY RECLASSIFICATION – Berlin, NH 110

Dear Ms. Laflamme:

This letter is to inform you of the official reclassification of NH 110/Jericho Road from the current limit of the Urban Compact, westerly to the intersection of Jericho Lake Road. This portion of NH 110 is being reclassified from a Class II state highway to Class IV highway. The reclassification was mutually agreed upon by the City of Berlin in accordance with the Extended Maintenance Agreement executed between the Department and the City and approved by Governor and Council on January 26, 2022, attached.

The City of Berlin will assume jurisdiction for, and in 5 years, full maintenance of this roadway via this letter under RSA 229:5 IV. A description of the area reclassified to a Class IV highway, provided for under the provisions of RSA 228:36, is as follows:

NH 110/Jericho Road

Beginning at the current Urban Compact limit westerly to the intersection with Jericho Lake Road.
