CITY MANAGER'S REPORT 04-15-2024


- 1. Attached is the March 2024 Real Estate Transfer Report.
- 2. Per City Ordinance Sec. 15-81, City's parking ban was lifted 4/1/24. During the month of April, the Police Chief is authorized to prohibit parking on City streets between the hours of midnight and 7:00 AM if required for snow plowing and removal operations.
- 3. Attached is the 2023 AVRRDD budget report, for your information.
- 4. Other than traffic after the event, the eclipse was uneventful. There were many people viewing the eclipse, both in the City and at the airport. Traffic was heavy prior to the event and after the event traffic heading south did not subside until after 10 pm. We did open the Emergency Operations Center and fortunately we did not have any serious incidents that occurred. The biggest impact was traffic heading south after the eclipse, as predicted traffic was extremely heavy as everyone left the north country after the eclipse.
