- 3. Oil and Propane bids went out April 14. The bid openings will be on April 28.
- 4. Brown School Grant Award.
- 5. Incoming City Manager Phil Warren was here Thursday for a second visit. He was able to meet with Superintendent King and visit Berlin Elementary School. He also was able to meet a few City Councilors. We set up his email and phone and started getting things ready for his arrival which is two weeks from today. Those of you who have not yet had the chance to meet him, we will work on setting that up for his first day.
- 6. Work is beginning on the house demolitions for the I&I Project. Abatement has begun on the properties that needed asbestos abatement. All-Ways Wrecking is still working on the exact schedule for which each property will be demolished, but it is looking like 825 Second Avenue will be happening soon as that is the only property that needs to adhere to a timeline set by Natural Resources it is near a nesting area of the Common Nighthawk so no work can be done on that property after May 15<sup>th</sup>. Eversource has finished all the official disconnects for each property as of last week.
- 7. Covid cases are on the rise for Coos County. This is informational only at this time and I am not suggesting that people do anything differently right now except if you are feeling sick/under the weather, please either stay home or wear a mask. Congratulations! On April 7, 2022, the Community Development Advisory Committee of the New Hampshire Community Development Finance Authority (CDFA) approved your CDBG application on behalf of TKB Properties, LLC in the amount of \$500,000, contingent upon the following:
