- 2. We have begun the transition from winter to spring maintenance, including street sweeping, repairs from winter maintenance, line painting and grounds cleanup.

- 7. I had a discussion with a property owner regarding dilapidated buildings, specifically the former motel next to Berlin Marketplace.
