ORDER AND HEARING NOTICE

The board has reviewed the June 11, 2021 filing by the "City" and the June 21, 2021

filing by the department of revenue administration ("DRA"). Both filings address the question

of whether the board should close this docket at this time. Cf. The board's March 17, 2021

Order (the "March Order"¹) at page 19:

[T]he board finds the work on the tax year 2020 update yet to be completed [by the City] also warrants keeping this docket open. The reasons for doing so stated in the DRA Post Hearing Memorandum, p. 15, are persuasive and have not been seriously challenged by the City... When a revaluation or update is performed, the USPAP manual must be satisfactorily completed and approved by the DRA. [Fn. omitted.] Consequently, the board will not decide whether to close this docket until the DRA confirms in writing that all of the outstanding issues noted with respect to the tax year 2020 update have been resolved.

In its filing, supplemented with various attachments, the City's attorney makes a "request

that this matter now be closed." In the alternative, he asks for "a specific itemize[d] list of open

issues and ... an opportunity" for a "hearing for the City to address any such issues."

¹ In reviewing the record, the board discovered an inadvertent and immaterial typographical error on page 15 of the March Order. The following correction is therefore made: "In the words of Mr. Gerry of the DRA, 'At a minimum, [the four abatements granted by the BOA] have the appearance of impropriety which is nearly as corrosive of the public trust as actual impropriety and . . . was completely **un**avoidable."

In its eight-page filing, supplemented with seven exhibits, the DRA's attorney itemizes alleged deficiencies in the City's compliance with the March Order, both with respect to the 2020 update ("Revaluation") and the board ordered assessment issues regarding the "Goddard," "Rozek Trust" and "T. Rozek" properties. He opposes closing this docket and states "the [b]oard should be prepared to conduct further proceedings and make further orders" and "the docket should remain open for further proceedings in this matter." (See DRA filing, pp. 2 and 8.)

Consequently, the board is scheduling a hearing on <u>Thursday, July 29, 2021 at 11:00</u> <u>a.m.</u> at the board's office at 107 Pleasant Street, Concord, New Hampshire, to allow the parties to present testimony, including testimony from Monica Hurley and Philip Bodwell, any additional evidence and arguments regarding the above disputed issues.

In accordance with Tax 208.05(a)(6), the City shall post copies of this Order and Hearing Notice in two public places in the City or in a newspaper of general circulation no less than ten (10) days prior to the hearing date.
